Sir,

It is stated that the inspection committee which inspected your college to check the compliance of previous conditions/shortcomings pointed out by the previous inspection committee, all the conditions mentioned in the previous affiliation letter and to verify the required infrastructural facilities, teaching faculty, other supporting staff and other amenities required to run the existing B.Ed course with an intake of 100 seats as per norms and standards prescribed by the University in the quantified inspection proforma to consider the matter of categorization of concerned college to be placed in category 'A', 'B' and 'C' (on the basis of available facilities/faculty/ other support systems) has submitted its report. The inspection committee on the bases of availability of qualified and approved existing staff and availability of infrastructural facilities has placed your college in Category 'A'

The report of the inspection committee has been considered by the Vice-Chancellor, who has ordered to ask the college to fulfill the deficient requirement of teaching faculty and shortcomings/deficiencies pointed out in the inspection report of the inspection committee. Accordingly, I have been directed to convey as under:-

- 1. To appoint the deficient teaching faculty/principal according to the prescribed qualifications/procedure of the University as per new rules circulated vide letter No. CB-III/10/108-401 dated 3.1.2011 (a copy of which can also be downloaded from the University Website www.mdurohtak.ac.com) and also to seek University approval of appointment of above deficient teaching faculty.
- 2. To appoint the Librarian, Non-teaching staff as per requirements of Central Body/University/State Govt. according to the prescribed qualification/procedure of the University and also to seek University approval of appointment of non teaching
- 3. To seek the individual approval of appointment in respect of the faculty members selection proceeding have already approved by the University and they are still on the role of the college.

- 4. To furnish an affidavit from 1st Class Magistrate with regard to separate building and land meant for the purpose of college exclusively in the name of institute/society with an undertaking that no other institute/school is running on the said land and building of the College.
- 5. To complete the deficiencies/shortcomings pointed out by the inspection committee in its report(copy enclosed)

I have further been directed to ask you to complete the above deficiencies /shortcomings and send compliance of the same to the University within a period of two month for necessary verification. On receipt of compliance report the University will get the compliance verified through an inspection committee of the University. After verification of the compliance, if your college is still found deficient suitable action will be recommended to the NCTE against your college and in that case the continuation in affiliation for B.Ed course for the next session i.e. 2012-13 shall not be allowed by the University till the completion of above deficiencies/shortcomings. Any violation in submission of compliance report with in the above prescribed period shall amount to violation of the University instructions and your college shall be inviting disciplinary action in terms of Act, Statutes and ordinances of the University.
