**ORDER**

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 N.R.B. College of Education, Plot No-145,146 & 147, Narnaul Road, Village-Khaira, Tehsil & District- Mohindergarh, Haryana had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission for starting B.Ed. course of one year duration with an annual intake of 100 (One Hundred only) students on 26.02.2008.

2. AND WHEREAS, the application was processed and inspection conducted U/s 14 on 14.09.2010 was placed in 167<sup>th</sup> Northern Regional Committee held from 28-30 September, 2010 and the Northern Regional Committee decided a Show Cause Notice U/s 14(3)(b) of NCTE Act 1993 be issued to the institution before refusing the recognition of proposed B.Ed. course on the certain grounds. Accordingly Show Cause Notice U/s 14(3)(b) was issued to the institution on 22.10.2010.

3. AND WHEREAS, the reply of the institution was considered in 173<sup>rd</sup> Northern Regional Committee Meeting held from 24<sup>th</sup> to 26<sup>th</sup> November, 2010 and the Committee decided to issue Letter of Intent Prior to recognition under clause 7(9) of NCTE Act, 1993. Accordingly a letter of Intent Prior to recognition was issued to the institution on 11.12.2010.

4. AND WHEREAS, the reply of the institution was considered in 175<sup>th</sup> Northern Regional Committee Meeting held from 30<sup>th</sup> to 31<sup>st</sup> December, 2010 and the Committee decided that the institution be asked to clarify its position on certain points and submit reply within 30 days. Accordingly a letter was issued to the institution on 27.01.2011.

5. AND WHEREAS, the reply of the institution was considered in 178<sup>th</sup> Northern Regional Committee Meeting held from 08<sup>th</sup> to 10<sup>th</sup> February, 2011. The reply of the institution dated 17.01.2011 has been considered. Formal recognition order under clause 7(11) of NCTE Regulation, 2009 and in terms of section 14(3)(a) of NCTE Act, 1993 be issued for 100 intake, for the session 2011-12, with usual condition.

6. Now THEREFORE, in exercise of the powers vested under section 14(3)(a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants/permitted recognition to N.R.B. College of Education, Plot No-145,146 & 147, Narnaul Road, Village-Khaira, Tehsil & District- Mohindergarh, Haryana (HR-1504) for B.ED. of one year duration with an annual intake of 100 students under clause 7(11) of NCTE Regulations subject to the following conditions:-

- 1) The admissions of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of the students shall be completed well before the cut off date prescribed by the examining body for the academic session 2011-2012 failing which the recognition will be effective from the academic session 2012-2013.
- 2) Formal order for recognition/permission will operate for 2011-2012 only if the requirement of 200 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body failing which the recognition will be effective from the academic session 2012-2013.
- 3) The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund in the joint name of an authorized representative of the management and the Regional Director, Northern Regional Committee.
- 4) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- 5) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations.

7. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

8. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

9. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.

10. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

- Copy of the Application Form
- Land and Building Particulars
- Staff Profile
- Recognition letter
- Information for having fulfilled the norms & standard and other required conditions.

11. In case if the land is in the name of the Society, the institution must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.
